

## **PARTICIPANT CONSENT AND RELEASE FORM**

**PLEASE READ THIS FORM CAREFULLY, THEN COMPLETE AND SIGN IT. THIS FORM PROVIDES FOR CONSENT TO RADIUS CAMP ACTIVITIES, WAIVER OF RIGHTS, AND CONSENT TO EMERGENCY MEDICAL TREATMENT AND MEDIA USAGE.**

We hereby acknowledge, agree, and consent to the following, as a condition of the below-listed Participant's ("Participant") participation in Radius Camp's ("Radius") camp activities.

1. The Participant is a volunteer participant in Radius's camp activities. Such activities may include but are not limited to interactive games, meals, worship services, construction projects, gardening, labor in warehouses, or running events on behalf of other local non-profit organizations. Such activities are collectively referred to as the "Program."
2. The nature and extent of the Program has been explained fully to us. We acknowledge that the Program requires **strenuous physical activity**. We acknowledge that the Participant is sufficiently mature and physically able to participate in such Program. We certify, to the best of our knowledge, that the Participant has no physical condition that will be aggravated by the Program or that will impair the Participant's ability to participate in the Program. In particular, we acknowledge the risk of serious injury and/or death from the Program, including the following: **concussions and other injuries during camp games; injuries from equipment or during tasks on mission sites; injuries from other camp participants; equipment malfunction; and weather-related risks.**
3. We hereby agree to fully cooperate with the Radius personnel in order to minimize the above-listed risks, including but not limited to our prompt disclosure of any future health-related issues related to the Participant's full ability to participate in the Program, postponement or cancellation of Program activities in the event of adverse weather-related conditions, and compliance with other Radius guidelines and directives.
4. We hereby release and discharge Radius's directors, officers, other volunteers, employees, coaches, sponsors, and other agents and representatives (collectively "Radius") from any and all liability, claims, demands, or causes of action that we may hereafter have for injuries or damages arising out of the Participant's participation in the Program, except for Radius's gross negligence or intentional misconduct in connection with the Program. We further agree that none of us will sue or make claim against Radius for damages or other losses sustained as a result of the Participant's participation in the Program, including but not limited to the above-listed risks. We also agree to indemnify and hold Radius harmless from all claims, settlements, judgments and costs, including but not limited to attorneys' fees, and to reimburse Radius for any expenses whatsoever incurred in connection with an action brought by the Participant or on his/her behalf as a result of participating in the Program.
5. We hereby give consent to Radius to authorize treatment on the Participant's behalf in the event of an emergency or illness, as provided below. We agree to reimburse Radius for any and all costs incurred for such care.
6. We hereby grant permission for the use of the Participant's name, photo, and/or video footage in connection with Radius's Program, including use on Radius's website and social media accounts.

*\*Radius will have a merchandise booth with t-shirts, water bottles, etc. available for purchase. We accept cash and most major credit cards (No Amex).*

*\*Radius will communicate requirements of any supplies for the mission site work to the Participant's Group Leader, e.g. work gloves, safety glasses, etc.*

*\*Radius will make sure there are water coolers on your mission site and around our host facility. However, Radius Camps does not provide disposable cups. Please bring your own water bottle to fill up at our water coolers at camp. Radius Camps will also have reusable bottles available for purchase at our camp store.*

*\*Radius does not have a strict cell phone policy, however Radius will support any church group who decides not to allow cell phones within their group. Radius reserves the right to remove a Participant's cell phone if it becomes a distraction.*

- Valuables
- Energy Drinks
- Alcohol
- Tobacco
- Illegal drugs
- Fireworks
- Any kind of weapon
- Radios
- MP3 players
- Water guns
- Water balloons
- Skateboards
- Roller blades

## CAMP RULES

- Be respectful of everyone at camp and on your mission sites and in the community.
- Treat our host facilities with respect. Negligent damage will not be tolerated.
- Be safe! Don't do anything that will cause you or another harm.
- Wear your nametag throughout the week. These may be removed at your mission site.
- Wear closed toed shoes and appropriate clothing on your mission sites.
- Participants are only allowed in the sleeping areas of their own sex.
- Lights out is each night at 10:30pm. We will be strictly enforcing this policy.
- All participants need to be fully clothed in any public space. This includes boys going to/from showers.
- No one is allowed off-campus unless accompanied by an adult leader from their group.
- Sexual misconduct will be grounds for immediate dismissal from camp.

The Participants's Group Leader at camp has authority to discipline as they deem appropriate. Radius Camp will support the discipline strategy of the Group Leader unless the Camp Director believes further discipline is required. In the case of continued inappropriate behavior, the Camp Director and the Participant's Group Leader will meet to determine the appropriate action. Radius Camps reserves the right to send a student home in case of continued inappropriate behavior at the expense of the student.

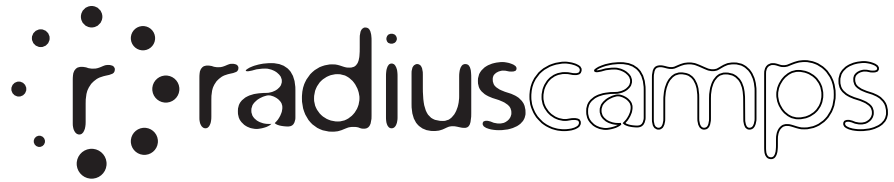
